

# DIVISION 'A' NEW HAVEN ADDITION SCALE: 1"=100"





This survey was done at the regust of Joe Cox, owner of the land within. Mr. Cox wanted to adjust his North line to be coincident with the existing fenceline. I find the pins set by Surveys 18-89, 64-72 and Minor Partition 1994-06 as shown on the map. The positions of these pins are harmonious with the dimensions of the blocks of Division A as established by Survey 70-77. The original plat of New Haven Addition has some discrepancy in the widths of the Northern tier of lots, so proportion was based on distances of the McLain La Grande monumentation survey (Survey 18-89). All of Lots 6 and 7 were in the ownership of Timothy and J. Grace O'Leary (Book 145, Page 199). The first division took place in 1965, which sold the tract to the South of the Cox tract (Book 151, Pg 207). The Cox tract was the next to be conveyed away (Book 152, Page 153), leaving the remainder of Lot 6 to be conveyed with Lot 7 (Book 153, Page 377). I therefore give full measure to the Cox tract and to the tract South of Cox, making lines parallel with the South line of Lot 6. The fence on the East line of the Cox tract falls off the property line as shown. This survey is being done in preparation for a minor partition. As a condition of approval of the minor partition, the city is requiring the Depot Street right of way to be dedicated 20 feet from centerline. The dedication is to be done by deed, filed separately. I place the pins based on the location of the new right of way line. I find no other unusual conditions with this survey.
