THIS SURVEY WAS PERFORMED IN OCTOBER AND NOVEMBER OF 2020. THE SURVEY EQUIPMENT USED CONSISTED OF A LEICA DUAL FREQUENCY GPS RECEIVER (GS14 ROVER) AND A LEICA DATA COLLECTOR (CS15).

ALIGNMENT MONUMENTATION

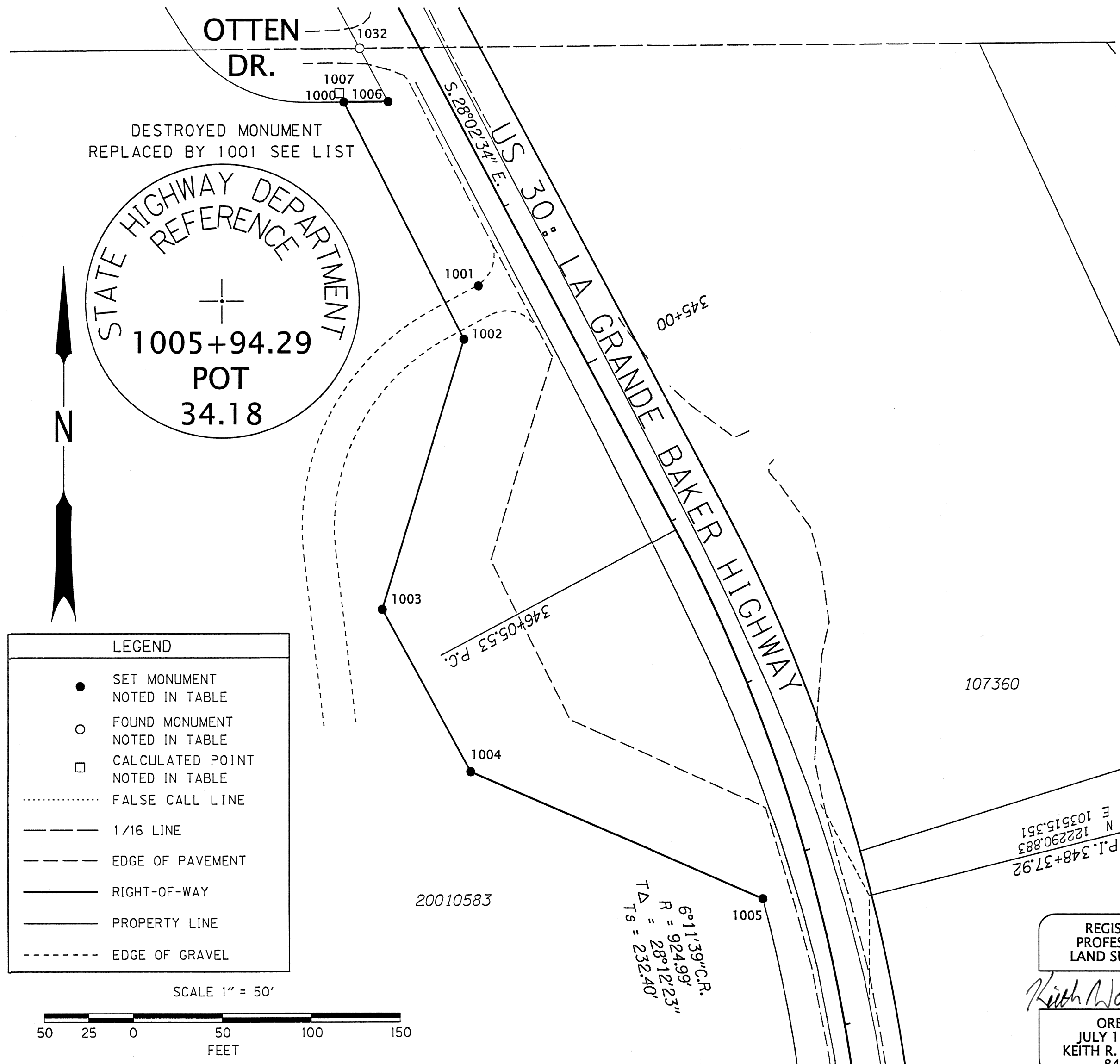
THE BEGINNING OF THIS MONUMENTATION SURVEY IS AT STATION (STA) 343+00 AND IT ENDS AT STA 348+20 ON US:30. THE ALIGNMENT USED FOR THE R/W IS FROM THE RESOLVED R/W RECORD OF SURVEY, UNION CO. SURVEY NUMBER 044-2017. THE R/W MONUMENTATION WAS ESTABLISHED UTILIZING THE ODOT RESOLVED ALIGNMENT AND THE STATION AND OFFSET CALLS GIVEN ON ODOT DRG. 1R-4-1306. THE CALLS ARE RELATIVE TO THE CENTER LINE OF HIGHWAY US:30. R/W MONUMENTS WERE SET ON THIS SURVEY BY RADIAL STAKEOUT UTILIZING GPS, THE OREGON REAL TIME GNSS NETWORK (ORGN) AND THE OREGON COORDINATE REFERENCE SYSTEM (ORCS).

BASIS OF BEARING

THE BASIS OF BEARING WAS ESTABLISHED UTILIZING THE DATUM REALIZATION OF NAD 83(2011) EPOCH 2010. COORDINATES ARE BASED ON THE OREGON COORDINATE REFERENCE SYSTEM (ORCS) LA GRANDE ZONE, INTERNATIONAL FEET.
