

LEGAL DESCRIPTION

Situated in the South half of the Southeast quarter of the Northwest quarter of Section 7, Township 4 South, Range 40 East of the Willamette Meridian, being a portion of Parcel 1 of Partition Plat 20130011T, filed as Microfilm Number 20132464T and stored in Slides 226 and 227, Plat Cabinet 'D', plat records of Union County, Oregon, more particularly described as follows:

Beginning at the Southwest corner of said Parcel 1,

Thence: South 89°47'05" East, along the South line of said Parcel 1, a distance of 281.73 feet, to the Southwest corner of Parcel

Thence: North 0°05'19" East, along the line common to said Parcels 1 and 2, a distance of 420.71 feet, to the Northwest corner of said Parcel 2,

Thence: South 89°45'13" East, along the line common to said Parcels 1 and 2, a distance of 215.65 feet,

Thence: North 0°14'47" East, a distance of 57.99 feet,

Thence: North 85°05'47" West, a distance of 499.30 feet, to the West line of said Parcel 1,

Thence: South 0°05'19" West, along said West line, a distance of 519.40 feet, to the Point of Beginning.

ALSO INCLUDING, an easement, 30 ft. wide, for ingress, egress and utilities, over a portion of Parcel 1 of Partition Plat 20130011T, more particularly described as follows,

Beginning at the Northeast corner of Parcel 2 of said Partition Plat 20130011T,

Thence: North 89°45'13" West, along the North line of said Parcel 2, a distance of 228.62 feet,

Thence: North 0°14'47" East, a distance of 30.00 feet,

Thence: South 89°45'13" East, a distance of 228.54 feet, to the East line of said Parcel 1,

Thence: South 0°05'19" West, a distance of 30.00 feet, to the Point of Beginning

Containing 3.615 acres.


