3 **1.0 INTRODUCTION**

4 Exhibit Z shows that the application submittal requirements of the Cooling Tower Impacts
5 Standard, Oregon Administrative Rule (OAR) 345-021-0010(1)(z), do not apply to the Boardman
6 to Hemingway Transmission Line Project (Project).

7 **2.0 APPLICABLE RULES AND AMENDED PROJECT ORDER**
8 **PROVISIONS**

9 **2.1 Site Certificate Application Requirements**

10 OAR 345-021-0010(1)(z) provides that, “[i]f the proposed facility has an evaporative cooling
11 tower,” Exhibit Z must include certain information about the cooling tower plume.

12 **2.2 Amended Project Order Provisions**

13 The Amended Project Order provides that the provisions of OAR 345-021-0010(1)(z) do not
14 apply to the Project.

15 **3.0 ANALYSIS AND CONCLUSION**

16 The Project does not include constructing or using an evaporative cooling tower, and therefore,
17 OAR 345-021-0010(1)(z) is not applicable to the Project, and Exhibit Z does not need to include
18 the cooling tower plume information provide for in that rule.
